## **PEACE BUILDING AND CONFLICT TRANSFORMATION**

### **Introduction:**

A network project of 10 NGOs with the theme "Peace building and conflict transformation" was initiated during the year 2010 – 2011. SWAD, Rayagada as a legal holder of the project supported by misers. PRAVA is one of the active partners.

### **Vision:**

To build a just equitable, peaceful, harmonious inclusive and self-reliant society that is rooted in love.

### **Mission:**

To promote livelihood, education, health, gender equity, environmental justice, human rights and dignity of all especially that of the poor and the marginalized such as tribals, dalits, women and children through the process of non-violence conflict transformation and participation sustainable development.

### **Activities of Peace building project:**

PRAVA Working as partner of SWAD under Peace Initiative project in K. Sitapur panchayat of Kasinagar block of Gajapati in the following 10 villages:

**Other activities taken:**

**Govt. schemes linkage and collaboration**

- 1) 5 VPDC mobilized sunflower seeds from Agri. Dept. On subsidized price.
- 2) Vegetable seeding mobilized from horticulture dept. For 28 farmers of 5 VPDCs on free of cost as a part of promotion of vegetable cultivation.
- 3) Distributed horticulture plants such as Papaya, drumstick in Benariguda and Mettakotturu village with the help of Horticulture department. Total 24 beneficiaries are benefited from this activity. The beneficiaries are taken the plants by paying Rs.2/- per plant on subsidy.
- 4) In the village Benariguda with our linkage the Horticulture department provided mango plant to 30 farmers in the month of May 2016. The farmers planted the plants as per the direction and method of planting. In our last visit we found that all the plants are survive.
- 5) In the village Ippaguda the VPDC planed with collaboration of Agriculture department with the facilitation of PRAVA for intercropping of raggi and Arhar in line planting. Total 13 farmers cultivate in 11 acre of land.

On the Quarter July to September 2016 mobilised mango plants from Horticulture departments. Under this activities covered the beneficiaries of Benariguda and Ippaguda those who are left out in previous year and also made gap filling. Total 68 house hold covered under this activity.

Collaboration with Agriculture department Planed to cultivate Sunflower in 42 acres. Is activity mobilised from Agriculture department and the beneficiaries are already selected. Total 51 house hold selected from 10 villages.

Apart from it mobilised for Potato and Onion cultivation from agriculture and Horticulture departments for 38 farmers in 10 villages. Total 17 acres of land is under preparation for this cultivation.



➤ **Different Govt. meeting / Trainings participated.**

- 1) Participated in training on the pulse polo program organized by CHC, Kasinagar
- 2) Participated in the workshop on MNREGA organizing by block for effective implementation.
- 3) Participated in Akasy Trutiya programme organized by agriculture department at Kasinagar on 09.05.2016.
- 4) Visited horticulture department and discussed with department personnel's on plantation method and techniques for the papaya & drumsticks plants on 05.06.2016, 09.06.2016, and the plants transported to the villages on 13.06.2016.

• **Ration card:**

From 10 villages 20 household those who are really eligible for get ration card selected through village meeting are applied for ration card.

• **VHND:**

During the year G.P Supervisor attended 35 VHND camps out of 48 and ensures community participation through awareness on the importance of VHND camps. 4 Institutional deliveries were conducted with PRAVA facilitation and the family comes linkage with MAMATA Yojana.

• **AWW Centre Survey:**

AWCs survey done in 9 villages out of 10 villages. Baseline Assessment Process of MTELP. Govt. Dept.
